To SATISFY the 4+3 BA/BS – JD Law Program (and earn admission to the USF Law School and a renewable Double Dons scholarship of at least \$40,000 per year), I understand that:

- I must have a cumulative GPA of at least 3.5 for all my course work. \_\_\_\_\_
- I must achieve an LSAT score at least equal to, or greater than, the law school’s first-year class median from the prior year. \_\_\_\_\_
- If I take the LSAT more than once, I understand that **the HIGHEST of the scores** will be used to determine my eligibility. LSAC permits students to take the LSAT **no more than 5 times in a 5-year period.** \_\_\_\_\_
- I must submit my completed Application for Enrollment to the USF Law School (using the regular admissions form) NO LATER than the PRIORITY DEADLINE. \_\_\_\_\_

(NOTE: THE LAW SCHOOL ACCEPTS STUDENTS ONLY FOR THE FALL SEMESTER IN ANY GIVEN YEAR).

- I understand I must also satisfy all other requirements for applying to the USF School of Law, including the submission of a personal statement, two letters of recommendation, and a LSDAS Report with a VALID LSAT score(s). \_\_\_\_\_
- I understand my application will be reviewed by the Law School Admissions Committee to ensure there are no character and fitness issues that would prevent admission to the bar. \_\_\_\_\_

Please note that enrollment in the 4+3 Program does not commit successful applicants to attend USF Law. The commitment date is the same for all applicants.

Also note that Double Dons scholarships are not guaranteed in the case of applicants who take gap years. Scholarships will be awarded on an *individualized* basis should an applicant take a gap between their undergraduate and law school education.

I fully understand the aforementioned requirements to be eligible for admission under the 4+3 Program at the USF Law School, and I understand that a failure to meet any of the requirements will disqualify me from automatic admission.
